**BRIEF DESCRIPTION**

This course will focus on Latin American visual arts from late 19<sup>th</sup> Century to contemporary production, making a special emphasis on the cultural diversity of the area. Both visual arts and literature will be explored from a critical perspective, taking a postcolonial/decolonial approach as a starting point.

**TOPICS INCLUDE – Syllabus**

1. The diversity of a continent and postcolonial/decolonial approaches. Alternative narratives, new cartographies and the search for forgotten visual and written texts. Methodological problems and the impact in contemporary narratives and narrations
2. Independence and the search for a “national style”: diversity and sameness as cultural strategy. Academies and the European tradition: looking for similarities and diversity
3. Travellers and the construction of the “exotic” in Latin America: rereading Edward Said, again
4. The popular and the political: from etchings to murals. Mexico as a case study. Diego Rivera and American art during the 1930s
5. “Indigenism”, otherness and other Surrealist fascinations
6. Across the Ocean: transatlantic and transcontinental relationships. European and American influence in Latin American or the other way round
7. Latin American photography: documenting documentary
8. When 1945 is not a key year in cultural history: Brazilian and Argentinian “Concretismo” versus Minimalism
9. Erased narrations: the importance of Sao Paulo Biennale in the international scenario of Modernity
10. Latin American visual arts away from home: chicano art and other new approaches to multiculturalism. Lucy Lippard’s cultural critique
11. Making Latin American visual arts visible. The New York art market during the 1980s and the open discussion: what do we mean by “Latin American art”?
12. Latin American Visual Arts/Visual Arts in Latin America: towards a new cartography
